Thank you for your request for information received at Northampton General Hospital NHS Trust (NGH) on 17/02/2019.

I am pleased to be able to provide you with the following information:

1. Have you used a Direct Engagement firm?

Yes

2. If so please list all you have used with dates.

One company has been used; 247 Time. This firm was used prior to the start of the IR35 change as the Trust already had a rolling arrangement with them.

3. For the purposes of IR35 assessments, do you claim to supervise direct and control (SDC) your temporary workforce (temporary staffing/finance will know) – and have policy relating to this?

If the worker is covering a substantive position (eg vacancy cover), then the Trust will supervise, direct & control the temporary worker & the worker will be deemed to be inside IR35.

Workers deemed to be outside IR35 will be completing tasks against an agreed project plan with predetermined timescales. The deliverables will be reviewed, but the worker will not be subject to supervision, direction & control in how these are achieved as an employee would be.

The Trust has an internal procedure for carrying out IR35 Assessments.

There are some instances when a detailed IR35 assessment is not required. This can be if certain criteria are met, eg arrangements not similar in nature to employment or the service is outsourced.

For roles requiring a detailed assessment, the procedure includes the completion of a questionnaire by the relevant manager in regard to the role of the temporary worker. The answers given generally determine whether the worker is deemed to be inside or outside IR35.

4. If you have outsourced this IR35 assessment function, did you claim to supervise, direct and control your temporary workforce prior to doing so?

The IR35 assessment function has not been outsourced.
