I write in response to your request under the Freedom of Information (FOI) Act.

I confirm that the Trust holds the information you requested. Please see the replies, set out against your questions, below:

- 1) *How many pregnant women receiving antenatal care by your trust were rated/considered to have*
 a) *a low risk pregnancy (- or whatever the equivalent term is your trust uses to describe an uncomplicated pregnancy)*
 b) *a high risk pregnancy (- or whatever the equivalent term is your trust uses to describe a complicated pregnancy) in 2016, 2017, 2018 and 2019, and how many of these women were first time mothers-to-be? Please provide numbers as well as percentages for women in each category.*

- 4) *How many pregnant women receiving antenatal care by your trust were cared for by midwives and/or sonographers only initially and were subsequently referred to obstetric specialists before they went into labour in 2016, 2017, 2018 and 2019? **

The required information would be recorded in the individual patient's notes. To extract this information, would require a manual review of each medical record; this would not be feasible as the time required to carry out this task would exceed the 18 hours allowed for a FOI request.
