## **About your Pre-Ambulatory** assessment

Please note this appointment is for an assessment not for the test and the monitor will not be fitted on the same day.

If you need any further information please ring us 01604 545724 Monday to Thursday 8.30am-4.30pm and 8.30am-3.00pm on Friday.

### **Pre-Ambulatory assessment**

Your doctor has asked us to perform a prolonged continuous EEG over 1-5 days to better understand your symptoms. This is called an Ambulatory EEG.

Often this is done to capture an episode or attack that you are having.

We would like you to come for a Pre-Ambulatory assessment to discuss the safety and procedures involved in this test and to get a better understanding of your symptoms. This assessment will take about 15 minutes.

PARENTS - If the appointment is for a young child or a child with special needs you may feel that they do not need to come to the assessment. Older children may benefit from seeing the equipment so we recommend they come with you.

# What do I need to do before the assessment?

You will be asked to tell us about your symptoms, how often they happen and things that you feel bring them on. It may be helpful to keep a diary of your symptoms and bring it with you to this assessment. You may also wish to bring someone with you to help you.

If you have any additional needs, including access due to disability or need for an Interpreter please contact us as soon as possible.

### **IMPORTANT INFORMATION**

You may need to make plans to have time off work or school whilst you have the Ambulatory monitor attached.

You may need to have someone with you during the monitoring to help record your symptoms.

Please think about these issues to help you plan the best time for your Ambulatory EEG to be performed.

## What will happen after the assessment?

If we feel Ambulatory monitoring will be helpful we will talk to you about when the test can be performed and for how many days.

You will be given an appointment letter confirming when you will have the monitor fitted.
